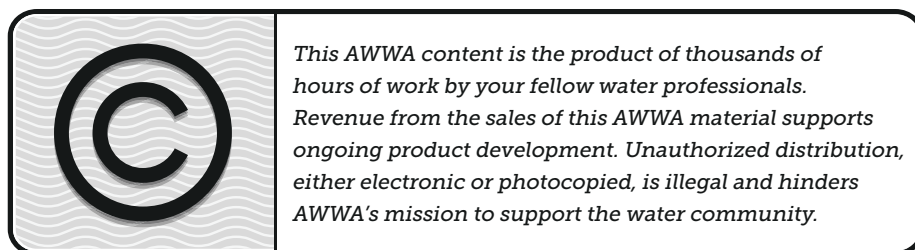
AWWA Standard
