This document (EN 15254-4:2018) has been prepared by Technical Committee CEN/TC 127 "Fire safety in buildings" (Secretariat: BSI, United Kingdom).

The responsible German body involved in its preparation was *DIN-Normenausschuss Bauwesen* (DIN Standards Committee Building and Civil Engineering), Working Committee NA 005-52-13 AA "Reaction to fire of building materials and building components — Fire resistant glazing".

Amendments

This standard differs from DIN EN 15254-4:2013-10 as follows:

- a) the term "glass product group" has been replaced by "glass product range";
- b) aspects which are now covered in the direct field of application of the standard DIN EN 1364-1:2015-09 have been deleted;
- c) exchange rules for fire resistant glass have been amended;
- d) an additional rule for the decrease in dimensions for fire resistant glazed elements with EW classification has been added;
- e) the standard has been editorially revised.
