It should be noted that, in Germany, CE conformity marking of construction products will be permitted once this standard has been listed in the *Bundesanzeiger* (German Federal Law Gazette) and from the date given therein.

National foreword

This standard has been prepared by Technical Committee CEN/TC 241 "Gypsum and gypsum based products" (Secretariat: AFNOR, France).

The responsible German body involved in its preparation was the *Normenausschuss Bauwesen* (Building and Civil Engineering Standards Committee), Technical Committee NA 005-09-10 AA *Gips und Gipsprodukte*.

Because not all of the content of DIN 18182-2: 1987-01, DIN 18182-3: 1987-01 and DIN 18182-4: 1987-01 has been replaced by DIN EN 14566: 2008 these standards have only been partially replaced by the latter. DIN 18182-2 has been revised and harmonized with the present standard, and is currently available as a draft standard (DIN 18182-2:2008-06). This revised version of DIN 18182-2, which is expected to be published at the end of 2009, will eventually replace DIN 18182-3: 1987-01 and DIN 18182-4: 1987-01.

Amendments

This standard differs from DIN EN 14566:2008-04 as follows:

- a) Normative references have been updated.
- b) Subclause 3.2 "Symbols and abbreviations" has been added.
- c) The web site address in NOTE 2 of clause ZA.1 has been updated.
