Amendments

This standard differs from DIN EN 13108-6:2006-08 and DIN EN 13108-6 Corrigendum 1:2008-06 as follows:

- a) new properties have been introduced (low temperature properties);
- b) additional optional sieves for the characterization of the grading have been introduced;
- c) for several properties additional categories have been introduced;
- d) specific conditions may now be defined in documents related to the application of the product;
- e) reference to the EU Construction Products Regulation and a new Annex ZA according to CPR rules have been included.
