- b) the abbreviation "Cost group (CG)" has been changed to "User cost group (UCG)";
- c) Clause 3 "Terms and definitions" has been specified and brought in line with DIN 276:2018-12;
- d) DIN 31051 has been included in Clause 3 "Terms and definitions" and thus also included in Clause 2 "Normative references":
- e) principles of user cost planning have been revised and expanded with the objective of making such planning more uniform;
- f) types of user cost identification have been expanded and editorially revised with a view to continuous planning of user costs;
- g) the cost breakdown structure of user costs has been generally revised.
