DIN 4228, February 1989 edition, has been superseded by the specifications of EN 12843.

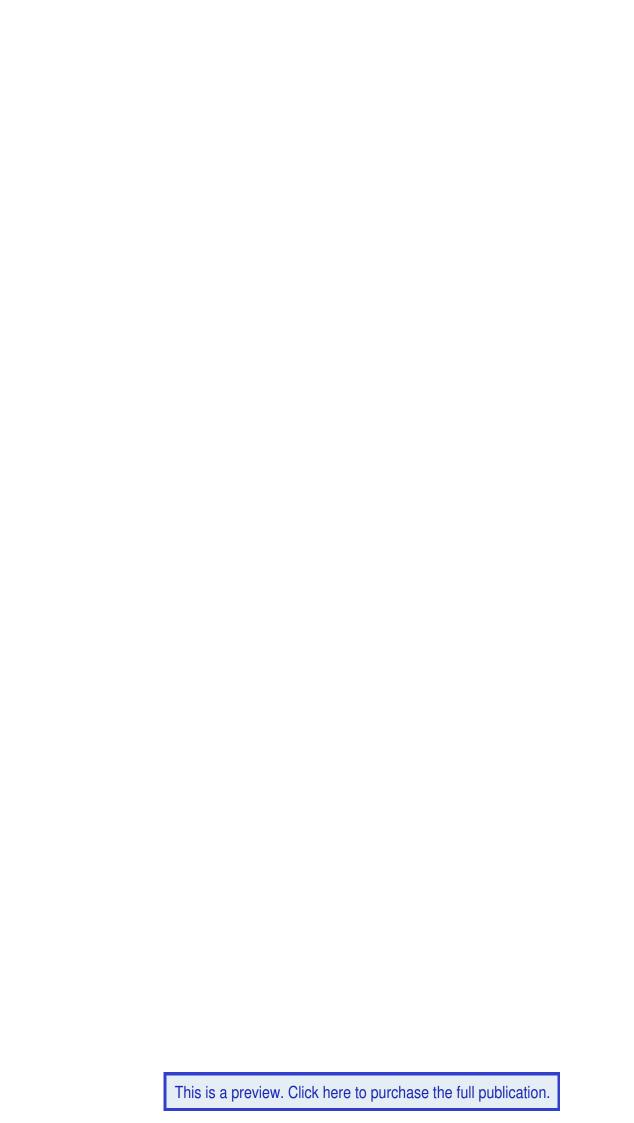
