This document is based on the English reference version EN 13977:2011.

Amendments

This standard differs from DIN EN 13977:2007-11 as follows:

- a) in Clause 3 “Terms and definitions”, “3.1 portable machine” and “3.2 trolley” have been rendered more precise;
- b) the former normative Annex I is now Subclause 5.19 “Noise reduction”;
- c) a new normative Annex H “Structure of European Standards for track construction and maintenance machines” has been added;
- d) Annex ZA (informative) “Relationship between this European Standard and the Essential Requirements of EU Directive 2006/42/EC” has been included.
