National foreword

This document (EN 13074-1:2019) has been prepared by Technical Committee CEN/TC 336 "Bituminous binders" (Secretariat: AFNOR, France).

The responsible German body involved in its preparation was *DIN-Normenausschuss Materialprüfung* (DIN Standards Committee Materials Testing), Joint Working Committee NA 062-03-32 GA "Joint working committee NMP/NABau/FGSV 7.2.0.1: Bitumen; test methods and specifications for binders".

Amendments

This standard differs from DIN EN 13074-1:2011-05 as follows:

- a) more precise requirements for the oven with forced air circulation (5.1) and the metallic plates (5.2) as well as for the placing of the plates inside the oven (7.2.2 and 7.3.2) have been added;
- b) a description of additional parts of the apparatus (beaker, oven) to be used for the reheating of the samples of recovered binders (5.5 and 5.6) has been added;
- c) EN 16849 can now be used for the determination of the water content of a bituminous emulsion (7.2.1.1);
- d) the storage period for samples of recovered binders before further testing has been shortened (7.2.3 and 7.3.3);
- e) more precise instructions (reheating temperatures and maximum reheating time) for the preparation of samples of recovered binders before further testing have been added (7.2.4 and 7.3.4).
