## **National foreword**

#### **Amendments**

This standard differs from DIN EN 445:1996-07 as follows:

- a) The standard has been editorially revised.
- b) The fluidity test using the immersion devices has been dropped.
- c) The fluidity test now also includes the grout spread method (see subclause 4.3.2).
- d) Grout spread testing now also includes the inclined tube test (see subclause 4.4).
- e) Determination of the volume change of the grout is no longer specified as a separate test method but has been included in grout spread testing as the wick-induced test (see subclause 4.5).
- f) A method of determining the density of grout has been specified (see subclause 4.7).
