National foreword

This document (EN 13108-21:2016) has been prepared by Technical Committee CEN/TC 227 “Road materials” (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was *DIN-Normenausschuss Bauwesen* (DIN Standards Committee Building and Civil Engineering), Working Committee NA 005-10-10 AA *Asphalt (SpA zu CEN/TC 227/WG 1) Gemeinschaftsausschuss mit FGSV*.

Amendments

This standard differs from DIN EN 13108-21:2006-07 and DIN EN 13108-21 Corrigendum 1:2009-05 as follows:

- a) the standard has been updated to be consistent with other parts of the EN 13108 series, test methods and CPR requirements;
- b) new guidance on non-conforming products, as part of factory production control, and on system non-compliance on audit has been provided;
- c) the term “constancy of performance” generally replaces “conformity of product”;
- d) Table A.1 has been split into Table A.1 and Table A.2 (correct tolerances for hot rolled asphalt mixes) for more clarity;
- e) the terms “additional characteristic” sieves for DoP purposes and “optional” sieves for the factory production control have been clarified;
- f) a factory production control system approach for a group of asphalt mixing plants or a single asphalt mixing plant for the audit has been included;
- g) the former (informative) Annex C has been dropped.
