Start of validity

This standard takes effect on 1 May 2009.

DIN EN 500-6:2007-03 may be used in parallel until 28 December 2009.

National foreword

This standard includes safety requirements.

This standard has been prepared by Technical Committee CEN/TC 151 “Construction equipment and building material machines — Safety” (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was the *Normenausschuss Maschinenbau* (Mechanical Engineering Standards Committee), Section *Bau- und Baustoffmaschinen*, Technical Committee NA 060-13-05 AA *Straßenbaumaschinen*.

Representatives of manufacturers of paver-finishers, of the responsible authorities, and of the employers' liability insurance associations contributed to this standard.

This standard contains specifications meeting the essential requirements set out in Annex I of the “Machinery Directive”, Directive 98/37/EC (valid until 28 December 2009), and the “revised Machinery Directive”, Directive 2006/42/EC, which takes effect on 29 December 2009, and which apply to machines that are either first placed on the market or commissioned within the EEA. This standard serves to facilitate proof of compliance with the essential requirements of the directives.

Once this standard is cited in the Official Journal of the European Union, it is deemed a “harmonized” standard and thus, a manufacturer applying this standard may assume compliance with the requirements of the Machinery Directive (“presumption of conformity”).

The European Standards referred to in this standard have been published as the corresponding DIN EN or DIN EN ISO Standards with the same number.

Amendments

This standard differs from DIN EN 500-6:2007-03 as follows:

- a) Annex ZB (informative) “Relationship between this European Standard and the Essential Requirements of EU Directive 2006/42/EC” has been added.


