The start of application of this standard is due to be 1 Oktober 2010.

DIN EN 14023:2006-01 may be used in parallel until October 2010 (see deadline in the EU Official Journal).

It should be noted that, in Germany, CE conformity marking of construction products will be permitted once this standard has been listed in the *Bundesanzeiger* (German Federal Gazette) and from the date given therein.

National foreword

This document (EN 14023:2010) has been prepared by Technical Committee CEN/TC 336 "Bituminous binders" (Secretariat: AFNOR, France).

The responsible German bodies involved in its preparation were the *Normenausschuss Materialprüfung* (Materials Testing Standards Committee) and the *Normenausschuss Bauwesen* (Building and Civil Engineering Standards Committee), Joint Committee NA 062-03-32 GA *Bitumen; Prüfverfahren und Anforderungen für die Bindemittel.*

Amendments

This standard differs from DIN EN 14023:2006-01 as follows:

- a) Clause 1 "Scope" has been extended to include the characteristics "brittleness at low service temperature" and "strain recovery";
- b) normative references have been updated;
- Subclause 5.3 "Release of regulated dangerous substances" has been added;
- d) the standard has been editorially revised.

Compared with DIN EN 14023:2010-08, the following corrections have been made to the German version only and therefore do not affect the English text:

- in Table 1, column "Force ductility", class 8, the temperature has been corrected to read "15 °C" (instead of "10 °C");
- b) in Annex A, characteristic "Cohesion", property "Tensile test", the indication "bei 5 °C" has been deleted.

Compared with DIN EN 14023:2010-11, the following correction has been made to the German version only and therefore does not affect the English text:

a) in Table ZA.3, the text in the left column *Aufgaben der Produktzertifizierungsstelle* has been replaced by *Aufgaben in der Verantwortung des Herstellers* (Tasks under the responsibility of the manufacturer).
