## Foreword

This document has been prepared by Working Committee NA 005-57-03 AA *Lastannahmen für Brücken* (SpA CEN/TC 250/SC 1/WG 2) of the Normenausschuss Bauwesen (Building and Civil Engineering Standards Committee).

This document is the National Annex to DIN EN 1991-2, *Eurocode 1: Actions on structures — Part 2: Traffic loads on bridges*.

European Standard EN 1991-2 allows national safety parameters, referred to as Nationally Determined Parameters (NDPs), to be specified for a number of points. The NDPs cover alternative verification methods, the provision of individual values and the selection of classes from designated classification systems. The relevant parts of the text are identified in the European Standard by references to the possibility of national choice and are listed in Clause NA.2.1. This National Annex also includes non-contradictory complementary information (NCI) for the application of DIN EN 1991-2:2010-12.
