Foreword

This document has been prepared by Working Committee NA 005-51-02 AA *Einwirkungen auf Bauten* (*Sp CEN/TC 250/SC 1*) of the *Normenausschuss Bauwesen* (Building and Civil Engineering Standards Committee).

This document is the National Annex to DIN EN 1991-1-6:2010-12, *Actions on structures—Part 1-6: General actions — Actions during execution*.

European Standard EN 1991-1-6 allows national safety parameters, referred to as Nationally Determined Parameters (NDPs), to be specified for a number of points. The NDPs cover alternative verification methods, the provision of individual values and the selection of classes from designated classification systems. The relevant parts of the text are identified in the European Standard by references to the possibility of national choice and are listed in Clause NA 2.1.

This National Annex also includes non-contradictory complementary information and explanations (NCI) for the application of EN 1991-1-6, as permitted by the European Commission's Guidance Paper L "Application and use of Eurocodes".

This National Annex is an integral part of DIN EN 1991-1-6:2010-12.

DIN EN 1991-1-6:2010-12 and this National Annex DIN EN 1991-1-6/NA:2010-12 supersede DIN 1055-8:2003-01.
