This standard differs from DIN EN 13481-5:2012-08 as follows:

- a) the Scope has been revised;
- b) the normative reference to EN 13146-10 has been included;
- c) the requirements in 5.8 “Cast-in and glued-in fastening components” have been revised;
- d) Annex ZA “Relationship between this European Standard and the Essential Requirements of EU Directive 2008/57/EC” has been revised and now refers to EU Regulation 1299/2014 (new TSI infrastructure).
