**JIS A 5423**: 2004 is revised as follows.

# 4.2 Characteristics of cement shingles for roofs

In table 3, replace the headword "incombustibility" with "incombustibility or heat generation property" and in the box below the headword, change the contents to "Incombustibility Class 1 or heat generation property Class 1".

# 6.1 Test piece

Add the following to the lower end of table 6:

Heat generation property	Height	50 or under	According to Annex A
test piece	One side	$99 \pm 1$	(normative)

## 6.11 Incombustibility test

Replace with the following:

- "6.11 Incombustibility test or heat generation test
  heat generation test shall be performed selecting either one of the following methods.
- a) Incombustibility test in JIS A 1321
- b) Heat generation test in Annex A"

Add the following  $\mathbf{f}$ ) under  $\mathbf{e}$ ), and replace the sentence "However, items  $\mathbf{d}$ ) and  $\mathbf{e}$ ) may be marked with some suitable method like an invoice and so on." with "However, items  $\mathbf{d}$ ),  $\mathbf{e}$ ) and  $\mathbf{f}$ ) may be marked with some suitable method like an invoice and so on":

f) Type and result of incombustibility test or heat generation test.
